Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2024-25 educational progress for Stephenson Area Public Schools. The AER addresses the complex reporting information required by federal and state laws. If you have any questions about the AER, please contact Renea Oskwarek, Superintendent's Administrative Assistant in the Superintendent's Office for assistance.

For the 2025-26 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student group in 2024-25. An Additional Targeted Support (ATS) school is one that had at least one student group performing at the same level as the lowest 5% of all schools in the state in 2021-22. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state, had a graduation rate at or below 67%, failed to exit CSI status in 2024-25, or failed to exit ATS status in 2021-22. Some schools are not identified with any of these labels. In these cases, no status label is given.

Stephenson Area Public Schools continues to focus on improving student achievement while addressing persistent gaps identified in the Annual Education Report data. Key challenges include variability in student performance across grade levels, particularly in mathematics and literacy, as well as achievement gaps among economically disadvantaged students and students with disabilities. Like many rural districts in the Upper Peninsula, SAPS also faces challenges related to enrollment fluctuations and limited access to specialized instructional resources. To address these concerns, the district has implemented targeted instructional supports, including increased use of data-driven decision making, intervention programming, and professional development aligned to identified needs. Through the MICIP process, SAPS has prioritized instructional consistency, strengthening Tier I instruction, and expanding targeted interventions to accelerate student learning and close achievement gaps.

State law requires that we also report additional information. To meet state requirements, the following information is provided for the two most recent years:

### **Process for Assigning Pupils to the School**

All students in grades K-12 who reside within the City of Stephenson are assigned to Stephenson Area Public Schools unless an alternative placement is selected through the School of Choice option.

### **Status of the 3-5 Year School Improvement Plan**

Since its adoption, Stephenson Area Public Schools has followed the Michigan Continuous Improvement Process (MICIP) model for school improvement. The district has established a MICIP team consisting of administrators and teachers representing the high school, junior high, and elementary. In addition to quarterly meetings with the district MICIP Coordinator, the team meets periodically to review progress, analyze data, and determine whether adjustments to the plan are necessary. SAPS is currently in the implementation phase of its five-year plan and has completed all required components to date.

### **Description of Specialized Schools**

Stephenson High School offers traditional in-person classroom instruction, online coursework, and Credit Recovery opportunities.

### **Core Curriculum Access and Implementation**

A copy of the core curriculum may be obtained from the Stephenson High School office. The district's curriculum aligns fully with Michigan Academic Standards and is implemented with fidelity across grade levels. There are no variances from the state's model. Aggregate student achievement results from local competency assessments and nationally normed tests in reading and mathematics are available via the link provided earlier in this report.

### **Parent-Teacher Conference Participation**

During the most recent school year, parent-teacher conferences were offered in-person. Approximately **81.9%** of K-5 parents participated and **37.6%** of 6-12 parents participated. Participation data is reviewed annually to identify strategies for increasing family engagement and communication.
